INVITATION FOR EXPRESSION OF INTEREST TO SUBMIT RESOLUTION PLAN FOR MASS METALS PVT. LTD.

1. BACKGROUND

Mass Metals Private Limited is a Private Company incorporated on 28 August 1990. It is classified as Non-govt Company and is registered at Registrar of Companies, Delhi. Its authorized share capital is Rs. 3,00,00,000 and its paid-up capital is Rs. 1,91,59,000. Its main course of business activity is metal trading and manufacturing.

Directors of Mass Metals Pvt. Ltd. is Mr. Rajesh Grover, Hitesh Chhabra, Anil Kumar and Pradeep Kumar Vashishtha as per the updated MCA records. Its registered address is Plot No. 49A, 1st floor, Street No. 30, New Rohtak Road, Anand Parbat, New Delhi, Central Delhi, DL 110005 IN.

At present, Mass Metals Pvt. Ltd. is undergoing a Corporate Insolvency Resolution Process ("CIRP") in accordance with the provisions of the Insolvency and Bankruptcy Code, 2016, ("IBC"). The CIRP of Mass Metals Pvt. Ltd. was initiated, pursuant to an order dated November 7th, 2019 of Hon'ble National Company Law Tribunal ("NCLT"), Delhi Bench.

NCLT vide its order dated November 7th, 2019 appointed Mr. Vishnu Dutt as Interim Resolution Professional ("IRP"). In the first CoC meeting held on 7th December, 2019, Mr. Ankit Kumar Agarwal was appointed as Resolution Professional and approved by the Hon'ble NCLT, New Delhi vide order dated 19.12.2019 (order received on 03.01.2020). The CoC has been constituted in accordance with the provisions of IBC and as decided by CoC, the RP is inviting the Expression of Interest ("EOI") from Potential Resolution Applicants ("RA") to submit the Resolution Plan. Form G -Invitation for Expression of Interest for Resolution Plans (Under sub-regulation (1) of regulation 36A of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016 ("CIRP Regulations") for the attention of the Prospective Resolution Applicants of Mass Metals Pvt. Ltd. is set out in **"Annexure – G"** hereto. It is clarified that the information memorandum, evaluation matrix and a request for resolution plans shall be issued in terms of Regulation 36B of CIRP Regulations [including Request For Resolution Plan (RFRP) and Ernst Money Depost (EMD)]

"ANNEXURE – A" ELIGIBILITY CRITERIA

The eligibility criteria for submission of Expression of Interest for submission of resolution plan for Mass Metals Pvt. Ltd. are as follows:

• To be eligible to submit EOI, the PRAs must satisfy the following eligibility criteria, as approved by the COC in accordance with Section 25 (2)(h) of the Code.

1) <u>Category A - For PRAs that are Corporates- Private/ Public Limited Company.</u> <u>LLP, body corporate whether incorporated in India or outside India</u>

- Minimum standalone Net worth (NW) of INR 1 crore as on 31st March, 2019 or latest available financial statements.

3) <u>Category C - Individual investor/ Consortium of individual Investors</u>

• **Minimum consolidated net worth of INR 1 crore at Individual level** Individual investor to include HUFs and family trusts.

• **Minimum consolidated net worth of INR 1 crore at Consortium level.** Net Worth of consortium shall be calculated as weighted average of individual member's Net Worth (value of negative Net Worth members shall be considered as Nil) basis their proposed participation in the consortium.

Potential Resolution Applicant must be eligible to submit Resolution Plan in accordance with provision of Section 29A of IBC as it stands after recent amendment. On 7th November, 2019, the Delhi Bench of National Company Law Tribunal ("**NCLT**") has directed commencement of corporate insolvency resolution ("CIR") process against Mass Metals Pvt. Ltd under the Insolvency and Bankruptcy Code, 2016 ("IBC"). Mr. Vishnu Dutt, a licensed Insolvency Professional, was appointed as Interim Resolution Professional of Mass Metals Pvt. Ltd by the NCLT by order dated 7th November, 2019. In the first CoC meeting held on 7th December, 2019, Mr. Ankit Kumar Agarwal was appointed as Resolution Professional and approved by the Hon'ble NCLT, New Delhi vide order dated 19.12.2019 (order received on 03.01.2020).

- **1.** On passing of the Order dated 19th December, 2019 by the NCLT, the powers of the board of directors of Mass Metals Pvt. Ltd. stood suspended and the powers of its board of directors were vested in Mr. Ankit Kumar Agarwal.
- 2. It is the duty of the Resolution Professional under the IBC to prepare an Information Memorandum ("IM") of the corporate debtor and invite the resolution applicants to submit a resolution plan.
- 3. Pursuant to the invitation for resolution plans from potential resolution applicants by the Resolution Professional, we are interested in submitting a resolution plan to the Resolution Professional.
- **4.** We require a copy of the IM of **Mass Metals Pvt. Ltd** and other additional information relating to Mass Metals Pvt. Ltd. and its subsidiaries that may be necessary to prepare a resolution plan of Mass Metals Pvt. Ltd. by us, either directly or through our affiliates, for submission to the Resolution Professional("**Transaction**").We note, understand and acknowledge that:
 - (i) You have prepared an IM of Mass Metals Pvt. Ltd. in terms of Section 29 of the IBC read with the relevant regulations framed under the IBC. We further note and understand that the information contained in the IM is confidential information and can be made available to a resolution applicant only after obtaining an undertaking of confidentiality as required under Section 29 of the IBC and Regulation 36 of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016 ("CIRP Regulations") only for the purpose of the Transaction;

- (ii) IM is prepared on the basis of information provided by the management of **Mass Metals Pvt. Ltd** and its creditors. No representation or warranty, express or implied, is given by the Resolution Professional or the advisors appointed by the Resolution Professional or any of its partners, directors, officers, affiliates, employees, advisors or agents (unless specifically mentioned under the provisions of the IBC) as to the accuracy or completeness of the contents of this IM or any other document or information supplied, or which may be supplied at any time or any opinions or projections expressed herein or therein;
- (iii) The IM is a dynamic document and may be updated from time to time till a resolution plan is approved by the CoC; Other additional information relating to Mass Metals Pvt. Ltd
- (iv) and its subsidiary company, if any, may be necessary for the Transaction;
- (v) Any additional or supplementary information or clarification besides the IM, including those provided by way of emails or on telephone or in meetings provided to us by the Resolution Professional or his team members, including legal advisors are also confidential in nature and shall be construed as a part of the IM.
- **5.** The IM, together with any additional or supplementary information (including the liquidation value of Mass Metals Pvt. Ltd. as and when made available) or clarification, including those provided by way of emails or on telephone or in meetings by the Resolution Professional or his team members, including advisors is referred to as "Confidential Information".
- 6. We are executing this undertaking of confidentiality to maintain confidentiality in respect of the information contained in the IM as mandated by the IBC and CIRP Regulations.
- 7. In terms of Section 29 of the IBC and Regulation 36 of the CIRP Regulations we unconditionally and irrevocably agree and undertake:
 - (i) to maintain confidentiality of the Confidential Information and not to use such Confidential Information to cause an undue gain or undue loss to ourselves or any other person.
 - (ii) in terms of Section 29(2) of the IBC, to
 - (a) comply with provisions of law for time being in force relating to confidentiality and insider trading in relation to such Confidential Information;
 - (b) protect any intellectual property of Mass Metals Pvt. Ltd
 - (c) and its subsidiary companies which we may have access to;
 - (d) not share this information with any third party unless it is shared on a strict need-toknow basis and clauses (a) and (b) above are complied with;

- (iii) Except as provided herein, we will not disclose the contents of Confidential Information, as updated from time to time, to any person other than to our affiliates, including, for avoidance of any doubt, our and their directors, officers, employees, agents or advisors, including, without limitation, financial advisors, attorneys, bankers, consultants and accountants, and potential financing sources (collectively, our "**Representatives**") who need to know such information for the purpose of the Transaction, provided that such Representatives are also bound by the same confidentiality obligations as us. We will be solely responsible for any breach of the provisions of this undertaking of confidentiality by any of our Representatives.
- (iv) We accept and acknowledge that the Confidential Information has been developed or obtained by Mass Metals Pvt. Ltd through investment of significant time, effort and expense, and that the Confidential Information is valuable, special and unique asset of Mass Metals Pvt. Ltd, which provides Mass Metals Pvt. Ltd with a significant competitive advantage, and needs to be protected from improper disclosures. We further understand and accept that the information contained in the Confidential Information, as updated from time to time, cannot be used for any purpose other than for the Transaction. Accordingly, weunconditionally and irrevocably agree and undertake to ensure that our Representatives agree to:
- maintain confidentiality of the Confidential Information, as provided from time to time, and not to use such Confidential Information to cause an undue gain to themselves /us or undue loss to any other person including Mass Metals Pvt. Ltd or any of its creditors and stakeholders;
- (ii) keep the Confidential Information safe in a secure place and protected against theft, damage, loss and unauthorized access and undertakes to keep all documents and other materials reproducing or incorporating confidential information separate from its own confidential information;
- (iii) protect any intellectual property of Mass Metals Pvt. Ltd that they may have access to; and
- (iv) use Confidential Information solely for the purpose of the Transaction and not for any other purpose.
- 8. Notwithstanding anything to the contrary contained herein, the following information shall however not be construed as Confidential Information:
 - (i) information is or becomes publicly available to us or our Representatives without breach of obligations as set out herein; or
 - (ii) prior to its disclosure in connection with the Transaction, was already in our or our Representatives' possession (other than such information made available by the Resolution Professional at any time during the CIR process of Mass Metals Pvt.

Ltd, which information shall be construed as Confidential Information and shall be bound by the terms of this confidentiality undertaking); or

- (iii) is or has been developed independently by us or our Representatives without reference to or reliance on the Confidential Information disclosed under this undertaking of confidentiality; or
- (iv) information was or becomes available on a non-confidential basis from a source that is not known by us or our Representatives to be prohibited from disclosing such information by any contractual, legal, or fiduciary obligation; or
- (v) prior consent by the Resolution Professional is provided for disclosure in writing; or

- **11.** We understand and undertake, in the event of abandonment of the resolution plan submission process and non-submission of the resolution plan; or not being shortlisted for the submission of the resolution plan; or our resolution plan not qualifying for being placed before the CoC; or the CoC rejecting our resolution plan; or the NCLT not approving our resolution plan; or in the event the Resolution Professional calls upon us in writing to do so, we shall immediately return or destroy the Confidential Information including the IM and other information provided by the Resolution Professional or its representatives, without retaining a copy thereof, in electronic or any other form. Notwithstanding anything stated therein, we are permitted to retain information pursuant to our automatic archiving and back-up procedures; provided however, that the copy/information retained by us shall not be used by us in any manner to causean undue gain to us or undue loss to any other person including Mass Metals Pvt.
