- ❑ Spanning in a total area of approx. 113335 sq. mtr. of which the factory premises admeasures approx. 41904 sq. mtr., our facility is equipped with all kinds of machines starting from rice stone separator, laboratory rice husker, length grader, rice grader machine to multi grader. Our infrastructure produces the most edible rice i.e. rice that is sufficiently milled and free of husks, stones, and other non-grain materials. Our packing machines allow us to offer customized packaging in any size and packing material as per client's requirement.



Key Investment Drivers

State-of-the-art Manufacturing Facility

- ❑ Japanese Technology
- ❑ Fully Automatic Plant with different-different stages to produce the best quality rice with minimal wastage
- ❑ Capacity is 12 MT per hrs.
- ❑ The state- of-art plant has special facility to grade rice through cylindrical indented screen rotating machine
- ❑ The broken/ small grains are lifted and removed through centrifugal cylinder.
- ❑ The rice color sorting with photo sensors/CCD (charged coupled device) i.e. sensor generated voltage signal removes discolored grains.



Key Investment Drivers

State-of-the-art Manufacturing Facility

- ❑ 3 cummins generators with 750 KVA, 400 KVA and 62.5KVA which are sufficient to run the full plants in case of power breakdown/ cut.
- ❑ The Plant has Thermax low pressure boiler and 3 brock silos.
- ❑ The plant has separate ETP plant with RO and Zero discharge. RO plant supplies purified water required in the production to prevent corrosion in machine and pipelines.



Key Investment Drivers

Strategic Location with Surplus Land

- ❑ Plant situated in khair village in Aligarh District UP, and is 130 KM from Delhi via Taj Express highway.
- ❑ Aligarh which forms part of western UP has extensive paddy fields to meet the paddy requirement of the plant.
- ❑ The total land area is around 28 acres with the factory premises in 10.35 acres and 17.65 acres outside the factory premises.
- ❑ This land can be used for multiple purposes including setting up of agro processing unit.
- ❑ The plant has a separate laborer colony comprising 2 floors for accommodating around 150 laborers.



Key Investment Drivers

Strategic Location with Surplus Land

- ❑ The Defence corridor is coming up within 20 km from the factory in next 2 years of time
- ❑ It is confirmed by Press Information Bureau Government of India on July 10th 2019 that land prices are likely to increase.
- ❑ During the Aligarh meet held on 11 August, 2018, investments of over Rs. 3700 crore were announced for Uttar Pradesh Corridor by DPSUs/OFB and Private industries.
- ❑ Equipped with modern facilities, a dedicated park for MSMEs is going to be developed soon in Aligarh's defence industrial corridor.



Key Investment Drivers

Strategic Location with Surplus Land

- ❑ UP govt. has approved widening of Palwal-Tappal-Aligarh Road (SH-22A) from two lanes to four lane, Ch 15.660 to 77.000 km & four laning bypass to Jattari Abadi (5.50 km) & Khair Abadi (10.00 km) (total length 67.500 km). This will improve the road connectivity and economic activity in the vicinity.
- ❑ Aligarh is a hub of plastic, software, medicine and hardware industry. A majority of hardware companies are in operation here. Improved road connectivity and infrastructure growth will invite even service sector to come up.
